

WAIVER AND RELEASE OF LIABILITY

I AGREE THAT THIS WAIVER RELEASE OF LIABILITY SHALL BE GOVERNED BY THE LAWS OF THE STATE OF VERMONT, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in, volunteering at or observing this event, I agree that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this event, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Vermont having jurisdiction. In the event any provision of this Waiver and Release of Liability shall be deemed invalid or unenforceable by any court, such provision shall be deemed severed from this Waiver and Release of Liability and replaced by a valid and enforceable provision which approximates as closely as possible the stricken provision.
